- a. Sanitary Facilities: The Government will provide portable sanitation facilities for the Contractor's use. If the Contractor elects to bring in his own sanitary facilities within the site boundaries, the Government shall provide waste removal services for Government provided facilities only.

- a. Sanitary Facilities: Contractors shall be required to provide adequate living conditions (sanitation, health, safety, living space) for their employees.
